FROM THE NATIONAL SECRETARY GENERAL - AN OVERVIEW

After the enthusiastic celebrations of our Golden Jubilee year (2013-14), we march ahead and it is my privilege to present the Annual Report of Bharat Vikas Parishad during its 51st year (2014-15) of service to the Nation. The main highlights of the work during the year were as under:

- National Council meeting was successfully held at Haridwar (Uttrakhand West) which was attended by about 1,250 delegates from all over the country.
- Meetings of the national bodies and workshops in respect of various faculties were organised during the year.
- All India National Group Song Competition, All India National Sanskrit Group Song Competition, All India Bharat Ko Jano Competition and Praudh Sadhana Shivir were hosted by Uttrakhand East, Maharashtra 1, Kashi Pradesh and Andhra Pradesh East respectively.
- A record number of over 1.80 lakh copies of "Bharat Ko Jano" book were distributed among the students participating in competitions. The number of students taking up written "Bharat Ko Jano" contest at branch level was 5.53 lakhs students attended BKJ written competition.
- During the year, number of branches and membership (families) raised upto 1,245 and 54,716 respectively. This represented an increase of 7 per cent branches and 3 per cent membership.
- Eleven new Vikas Ratna were enrolled taking the total number of Vikas Ratna to 137.
- Parishad has taken up integrated development of 37 villages spread over in 17 out of 29 states i.e. 59 percent of the states
 in the country. Total funds provided till date amount to Rs. 3.17 crore. The developed villages have significantly upgraded
 to the quality life style of the villagers.
- Parishad operates 1,216 permanent projects including 30 per cent health and medical care projects.
- Our major health centres continuously providing medical fecilities to the society. Number of patients benefited by our Chandigarh Diagnostic Centre reached upto 3.55 lakh. Super specialty Kota Hospital provided treatment to 1.80 lakh patients, performed 7,000 surgeries and over 1,500 eye operations. Similarly, Ludhiana Hospital provided medical services to 22,388 patients. Kota Hospital is also running a Nursing School as well as a College of Nursing with more than 300 students.
- Parishad's Viklang Kendras and branches provided artificial limbs and other aids to 13,595 physically challenged and rehabilitated 1,769 persons requiring assistance.
- As always, Parishad undertook quick relief and rehabilitation work when natural calamities hit Jammu & Kashmir, Bahraich (UP), Barhampur and Gopalpur (Orissa), and Kokrajhar (Assam).

I take this opportunity to thank all colleagues who worked tirelessly at the branch, state, zone and central levels for their cooperation in strengthening the organization in service of the Nation.

Newly Elected National Office Bearers Assume Charge

Newly elected National Office Bearers of Bharat Vikas Parishad took oath of their office for a two year term in April, 2014 - Shri Sitaram Pareek, National President; Shri Surinder Kumar Wadhwa, National Working President; Dr. Kanhaiya Lal Gupta - National Secretary General and Shri Sachidananda Panda, National Finance Secretary.

- 1.2 Unfortunately, our revered Dr. Kanhaiya Lal Gupta left for heavenly abode on the 10th January, 2015 while still serving as our National Secretary General. Parishad places on record the valuable contribution of our respected stalwart. In his sad demise, Bharat Vikas Parishad has lost a true Karmyogi a visionary, philosopher and guide.
- 2. Meetings at National Level.
- 2.1 Following National level meetings / workshops were held during the year 2014-15:

National Meetings

- i. National Council of Bharat Vikas Parishad held its meeting at Haridwar (Uttrakhand West) on the 20th and 21st December, 2014. (1) The fourth meeting of the National Council of Bharat Vikas Parishad was held at Haridwar (Uttrakhand West) on 20-21 December, 2014 which was attended by about 1,250 delegates. (2) Shri Suresh Bhaiya ji Joshi, Shri Madan Kaushik, MLA and Shri Manoj Garg, Mayor of Haridwar graced the inaugural function. (3) On the first day, there were sessions on Service, Sanskar and Organisation wherein presentations were made by the office bearers concerned with the subjects. In the evening was a captivating cultural programme organised by Parishad's members and their families. On the second day discussions were held on Sampark. During the deliberations, eight Vikas Ratnas were also falicitated.
- ii. **National Governing Board (Rashtriya Karyakari Mandal)** held its annual meeting at Somnath (Gujarat Central) on the 7th and 8th February, 2015. **(1)** The meeting was presided over by Shri Sitaram Pareek, National President. Shri Keshubhai Patel (former Chief Minister of Gujarat and Chairman Shri Somnath Trust) and Shri Praveenbhai Lahiri (former Chief Secretary of Gujarat and Secretary, Somnath Trust) graced the meeting. S/Shri Ravindra Pal Sharma (Ex. National President), Justice Vishnu Sadashiv Kokje (Ex. National President) and Shri K.B. Rama Rao were falicitated as Vikas Samparpit for their exemplary contribution and dedicating their best years of life to the organization. **(2)** The deliberations of the Board meeting were divided in five sessions where discussions were held regarding expansion of our work, as well as in regard to our Sanskar and Sewa projects. The delegates also had the privilege of listening to inspiring speech of Shri Bhagaiah ji. To fill the vacancy caused by untimely demise of Dr. Kanhaiya Lal Gupta, the Board unanimously elected Shri Ajay Dutta as National Secretary General. In the concluding session, Shri Sitaram Pareek, National President delivered his presidential address.

6.1 The extent of expansion of Parishad's work in <u>districts</u> is given below:

7. Vikas Ratna and Vikas Mitra

- 7.1 Parishad has two schemes "Vikas Ratna" and "Vikas Mitra" to provide funds for urgent relief works as well as for providing funds for various service projects / programmes. Presently, the minimum contribution expected for Vikas Mitra is Rs. 11,000. For enrollment as Vikas Ratna, the donor is expected to pay a sum of Rs. One lakh by Cheque / Draft or Rupees One lakh fifty thousand in the shape of an advertisement to the Parishad. The investment of such funds in FDRs, Bonds or Govt. Securities provides the much needed resources.
- 7.2 There has been encouraging response to the scheme. As on 31.03.2015, 137 Vikas Ratna and 3,424 Vikas Mitra were enrolled. However the new enrollment for year 2014-15 is **11** for Vikas Ratnas and **10** for Vikas Mitras.

PROJECTS & PROGRAMMES SANSKAR

8. National Group Song Competition (N.G.S.C.)

- 8.1 Ever since the first National Group Song Competition of patriotic songs was held in 1967, such competitions have become an annual feature generating patriotic fervor. This is one of our oldest projects and has come to provide a measure of Bharat Vikas Parishad's popularity and identity among the student community, their family members and the teachers.
- 8.2 The competitions are held for students from class VIth to XIIth at Branch, Prant and All India levels. Teams selected at Branch level compete at Prant level and those selected at Prant level finally compete at All India level. In the competition at the national level, a team from each Prant sings one patriotic song each in Hindi from "Chetna Ke Swar" and a regional language and the best teams are awarded prizes.
- 8.3 At branch level, the participation of students during 2014-15 has been as under:

- 8.4 Fortieth **All India National Group Song Competition** was held at Pantnagar (Uttrakhand East) on the 29th-30th November, 2014. A record number of 47 state teams participated from all over the country.
- 8.5 In Hindi Patriotic Group Songs, the First, Second and Third places were won by Haryana North, Delhi South and Rajasthan Central Prants respectively. Similarly, in Regional Songs competition, the First, Second and Third places were won by Orissa, Punjab North and Haryana North Prants respectively.
- 8.6 Among the guests who graced the occasion were Swami Devamitranand ji Maharaj, Shri Bhagat Singh Koshyri, ex-Chief Minister and Member of Parliament and Shri R.K. Agarwal, Managing Director, Shridi Industries. They appreciated the efforts of the Parishad in inculcating love for the motherland among the students through chorus singing of patriotic songs. Swami Madhav Prapannacharya ji was the chief guest in the concluding session and blessed the participants.

9. National Sanskrit Group Song Competition (NSGSC)

- 9.1 This programme was initially started as a competition for singing full text of Vandemataram to instill patriotic feelings among the children. Now in this competition, the first song is to be a patriotic song in Sanskrit, from among the songs prescribed by the Parishad in "Rashtra Geeetika", and the second is a folk song of any state. The competition is conducted at Branch, Prant and National Jevels.
- 9.2 At branch level, the participation of students during 2014-15 has been as under:

- 9.3 Tenth All India National Sanskrit Group Song Competition 2014-15 was held at Mumbai on 15-16 November, 2014. The event was hosted by Maharashtra I Prant. A record number of 45 teams participated in National Sanskrit Group Song Competition - both in Sanskrit Song and Folk Song competitions. In the inauguration session Swami Visheshwaranand ji and in the concluding session Shri Vidyasagar Rao, Governor of Maharashtra, graced the occasions.
- 9.4 In Sanskrit Song, the First, Second and Third places were won by teams from Kurukshetra (Haryana North), Bhilwara (Rajasthan Central), Satara (Maharashtra 2) respectively. Similarly, in Folk Song competition, the First, Second and Third places were won by Gujarat Central, Haryana North and Punjab South Prants respectively.

10. Bharat Ko Jano

- 10.1 "Bharat Ko Jano" is a quiz programme for the school children to increase their awareness about the distinctive features of our country and culture. This competition is being held at branch, prant and national levels. This programme has generated great interest among the students.
- 10.2 In the first stage written test in General Knowledge is organised in each participating school for both junior (class 6 to 8) and senior (class 9 to 12) levels. Each Branch then conducts Quiz Competition among the students standing first, second and third in written test. During the year, 1.80 lakh "Bharat Ko Jano" books are distributed among the school students for this competition.
- 10.3 During 2014-15, the participation of children in Bharat Ko Jano Competition was as under:

- 10.4 The teams which stand first in both the groups are selected for the competition at the Prant level. Similarly, the teams selected at Prant level compete at the National level.
- 10.5 The 14th All India Bharat Ko Jano Competition was held at Varanasi (Kashi Prant) on the 27th and 28th December, 2014. As many as **96 teams** - both Junior (49) and Senior (47) - from 49 Prants competed.
- 10.6 Shri Manoj Sinha, Minister of State for Railways, graced the occasion as the Chief Guest.
- 10.7 Results of the Competition were as under:

11. Guru Vandan - Chhatra Abhinandan

- 11.1 Primary purpose of this programme is to strengthen in the minds of children the idea of respecting their parents and teachers, whose blessings will enable them to be successful in life. Under this programme, the representatives of branches visit selected schools, colleges or any other institutions in and around their areas to express thanks and gratitude to the teachers and congratulate the meritorious students. The most important aspect of the program that makes it a special one is that the students are encouraged to take the blessings of teachers and parents by touching their feet.
- 11.2 Such functions are organised during the period from 1st April to 15th October every year. Ever since the programme was adopted at the national level in 2001-02, there has been a good response to this programme in which lakhs of students and teachers participate every year.
- 11.3 During 2014-15, over 10 lakh students participated in this programme as shown below:

On the whole, 17,802 students were felicitated and 10,644 teachers were honoured in various schools.

12. Guru Tegh Bahadur Balidan Diwas and Other Inspiring Events

12.1 Bharat Vikas Parishad has been observing the martyrdom day of Guru Teg Bahadur for many years. Public meetings, seminars and exhibitions are held to highlight the sacrificesof Sikh Gurus and pay respectful homage to the great patriot. During 2014-15, **201 branches** organised a total of **228 functions** in various parts of the country in which **35,001** participants paid their homage to Guru Teg Bahadur. In addition, 188 branches organised other 476 inspiring events in which **75,573 persons** participated.

13. Bal, Yuva and Mahila Shivirs

- 13.1 During the year 2014-15, 152 branches organised 237 Sanskar Shivirs wherein a total of 17,903 children and youth participated.
- 13.2 Similarly, during the year 2014-15, 81 branches organised 97 Mahila Sanskar Shivirs which were attended by 10,849 participants.

14. Praudh Sadhana Shivirs

- 14.1 The aim of Praudh Sadhana Shivirs is to prepare retired persons to lead active, purposeful and dedicated social life. During the year 2014-15, 30 branches organised **Sadhana Shivirs** wherein a total of 7,521 senior citizens participated.
- 14.2 The Twenty First All India National Praud Sadhana Shivir was organized at Annavaram on the 28th February & 1st March 2015. Andhra Pradesh East was the host Prant. As many as **464 delegates** from various Prants attended the Shivir. The largest contingent of 152 delegates had come from Andhra Pradesh alone. Sri Pari Poornananda Swamiji and Sri Radhananda Bharati Swamy inaugurated the shivir and provided guidance to the delegates. A Souvenir and a booklet were released by the Swamiji on this occasion.

SEWA

15. Viklang Sahayata Project (Handicapped Welfare & Rehabilitation)

15.1 Parishad has been serving the physically challenged brethren through its **13 Viklang Sahayata Kendras** located in various states as well through camps organised by Parishad's branches all over the country. The Viklang Sahayata Kendras manufacture artificial limbs and calipers, hearing aids, medicines, special shoes, and tri cycles. In addition, there are mobile workshops, which manufacture artificial limbs and service the Viklang Camps organised by various Branches.

15.2 During the year 2014-15, number of artificial limbs provided by the Viklang Kendras and the branches is indicated below:

(a) By BVP branches at Viklang camps (12,823)
 (b) By Viklang Kendras at their own centres (5,880)
 (c) By Viklang Kendras at camps organized b organisations other than BVP (1,620)
 Total (20,323)

15.3 Our Viklang Sahayata Kendras alone have so far provided artificial limbs to **over 2.27 lakh physically challenged** persons tile date.

15.4 In addition to providing artificial limbs, our branches also **rehabilitated 1,769 handicapped persons** by providing them training in various vocations, securing employment or in obtaining railway passes etc. during the year.

16. Villages / Urban Slums Development

16.1 Each branch is encouraged to adopt either a village or a slum area for its over-all development. During 2014-15, our branches took up 123 service projects in **46 villages**. The projects included health check-up camps, visit of mobile medical vans, vocational training centres, sanskar kendras and education of illiterate and neglected children. The centres also help in getting benefits of different schemes launched by the Government.

17. Integrated Development of Villages

17.1 Bharat Vikas Parishad has taken up Samagra Gram Vikas Project for all round development of villages in various parts of the country with financial assistance from Jindal Foundation Canada. 17.2 So far work in 14 villages has been completed while work in another 13 villages is nearing completion. In addition, during 2014-15, ten more villages were

identified for undertaking comprehensive development and there preparatory work has commenced. During the year Rs. 28.75 lakh were spent on the programme taking the total funds provided till date to **Rs. 3.17 crore.17.3** the status of **villages** taken up under this programme is indicated below.

It is notedl, on the basis of work taken up so far, 59 per cent of the states in the country 17states will have model villages developed by Bharat Vikas Parishad.

18. Vanvasi Sahayata Project (Tribal Development)

- 18.1 Bharat Vikas Parishad has been working for the welfare and uplift of the vanvasi of the country in general and North Eastern states in particular since 1992. Presently, Parishad has adopted a number of projects in the North Eastern states including Bongaigaon Hospital and number of hostels, Ekal Vidyalayas, libraries, vocational training centres, medical centres and solar lighting project.
- 18.2 During the year, a sum of Rs. 28.68 lakh was provided for Vanvasi Sahayata Project. Prants incurred expenditure amounting to Rs.26.40 lakh on projects in their own tribal areas. Further, the Central Office released financial assistance amounting to Rs.2.28 lakh for following projects:

19. Environment: 19.1 Bharat Vikas Parishad has launched "Green India Project" under which trees are planted by each of its branches. Similarly branches are to organize distribution of sacred plants like Tulsi for homestead planting in urban towns. During the year, our branches planted 66,241 plants and distributed 63,557 Tulsi plants – a total of **1.30 lakh plants**

20. Health (other than assistance to physically challenged)

- 20.1 Our branches regularly hold general health check-ups, blood donation camps and specialized medical camps e.g. dental care, eye care, T.B. camps, Hepatitis camps and camps for deaf etc. Facilities for registration of eye donation and surgery are also provided. Branches also regularly organise seminars on various aspects of health and conduct yoga camps. A number of hospitals and dispensaries set up by the Parishad are also serving the society.
- 20.2 The number of beneficiaries in the health camps organised by the branches during the year were as:
 No. of camps organised by branches **1,191**, No. of beneficiaries **2.21 lakh**, Blood donation by members **20408 Unite**.
- 20.3 Apart from organising health camps, Bharat Vikas Parishad has set up hospitals and diagnostics centres which provide advanced diagnostic and treatment facilities either free of cost or at highly subsidized rates in spirit of service to the citizens.
- 20.4 **BVP Hospital & Research Centre, Kota (Rajasthan):** Started in 1997 with a humble beginning, it is now a multispecialty 220 bedded hospital spread over land area of 54,000 sq. feet and constructed area of more than 60,000 sq. ft. Various departments functioning are General Surgery, Gyne, Orthopeadic, Peadiatric, General Physician, Eye, E.N.T, Cardiology, Dental, Physiotherapy, Dietician, Neuro Physician, Neuro surgery, Urology, cancer treatment, skin, etc. All the facilities of pathological diagnosis, Color Doppler, TMT, Angiography, Sonography, Digital X-Ray etc, are available in the Hospital. The facilities are available 24 hrs and emergency services are also provided.
- 20.5 Super Specialty services of advance Cath Lab, Dialysis, CT Scan fully are available. Fully equipped Otroke ICU, ICCU, PICU, and NICU with all modern equipments are also available. There are post operative wards, recovery rooms, deluxe rooms and separate general wards for male and female patients.
- 20.6 There are highly qualified and experienced medical consultants and dedicated staff. There are more than 50 consultants and 300 staff providing round the clock services for 365 days. There are five ambulances. The hospital is also running a Nursing School as well as a College of Nursing with more than 300 students.

- 20.7 The hospital started blood bank named BVP Blood Bank in Oct.2014 equipped with the latest machines. During the year, the hospital provided treatment to a total of **1.80 lakh patients**. In addition 40,000 patients were admitted in hospital for treatment in various departments. The number of **surgeries performed was more than 7,000**. More than **1500 eye operations** are performed each year in the remote areas free of cost.
- 20.8 **BVP Charitable Diagnostic Centre, Chandigarh:** One of Parishad's pioneering diagnostics centre is at Chandigarh. It has highly advanced diagnostic and treatment facilities including Pathological Laboratory, X-ray Centre, Ultra Sound Centre, Cardiac Centre, Eye Care Centre and OPD. The OPD presently provides consultation for Gynecology, General Medicine, Orthopedic, Skin, Paediatric, Gastrointestinal, Ayurvedic and Homeopathic consultation and prescription.
- 20.9 From 4,087 patients served during 1987-88 with limited facilities, the number of patients served is grown up to **3.55 lakhs** during 2014-15. Diagnostic Centre provides services on 'no profit no loss basis'. During 2014-15, a sum totaling **Rs. 6.49 crore** was collected from the beneficiaries for the services. These charges are one third and in many cases even one fourth of the normal market rates.
- 20.10 **BVP Charitable Trust Hospital, Ludhiana (Punjab)** The hospital also provided **medical services to 22,388 patients** who visited its polyclinic centre through its various Departments such as Physiotherapy, Homeopathy, General Medicine, Pediatrics, Gynea, Eye Dept., Dental, Acupressure and Acupuncture. The total number of patients who have benefited from the services of its Policlinic wing so far is 3.67 lakh.
- 20.11 During the year, 232 Handicapped persons were also rehabilitated. In Computer Training centre 80 students and in tailoring section 51 girl students were given training. Its Vocational Training Centre is equipped with computerized embroidery machine and semi auto flat knitting machine. Seventy one persons were given training during the year.
- 20.12 The total expenditure on various activities during the year amounted to Rs1.28 crore.
- 20.13 **BVP Punarvas Kendra & Sanjay Anand Viklang Hospital & Research Centre, Patna:** A Super Specialty Centre for prosthetic and orthotics, it has facilities for corrective and innovative surgery. Its Orthopedically Handicapped Surgery Unit and Physiotherapy Centre have state-of-the-art facilities. During 2014-15, apart from providing artificial limbs to 847 physically challenged persons, the centre conducted **polio and corrective surgery on 280 patients.**
- 20.14 **Delhi Bharat Vikas Foundation, Delhi:** During the year, the centre provided artificial limbs and other aids to **71,978 physically challenged.** The Foundation has since extended its activities to provide facilities for eye care, dental care, physiotherapy, X-Ray scan and Homeopathy. The number of beneficiaries in these departments during the year was **13,917**.
- 20.15 **Generic Medicine Facilities:** Parishad has set up a network of centres providing generic medicines to the public in Hyderabad and Secunderabad. These are named "Bharat Vikas Sanjeevani Generic Medical Shops". During the year two more centres were added to the existing centres to bring the total number of generic medicine centres to 13. These centres provide more than 350 medicines at very low rates compared to other commercial medical shops. This project also supports Mobile Medical Van which provides free services of qualified doctor, pharmacist and generic medicines in the selected slum areas. The generic medicine programme has led to their usage by Trust run Hospitals and BVP sponsored medical camps.
- **21. Samuhik Saral Vivah**: 21.1 Parishad has been organising Samuhik Saral Vivah of poor and needy young girls and boys as an important programme every year. During the year 2014-15, Parishad helped in organising marriages of **346 couples** belonging to weaker sections of the society.
- 22. **Relief Work**: 22.1 **U.P**: Relief in the form of medicines, food, clothing and shelter was provided to our brethren affected by floods in Bahraich (U.P.) during August 2014.
- 22.2 **Jammu & Kashmir**: In September 2014 heavy rainfall and landslides played havoc in Jammu & Kashmir, Parishad rushed urgently required supplies, including woolens, to the victims. Among others, Parishad is also funding construction of a temple there.
- 22.3 **Orissa:** When cyclone struck in Orissa in October, 2014, Parishad undertook repair of cyclone relief centre at Barhampur and renovation of old age home at Gopalpur.
- 22.4 **Assam:** In February 2015, about 2190 people from 490 families of seven villages in Kokrajhar (Assam) were taken in a camp after losing their houses which were blazed by Bodo Militants. Bharat Vikas Parishad organized free medical treatment and food supplies among people affected by the ethnic violence.

- 23. Permanent Projects: 23.1 There are now 1,150 permanent projects run by various branches of Bharat Vikas Parishad whose activities are conducted on daily or weekly basis for the benefit of the society. These projects include Hospitals, Clinics, Physiotherapy Centres, Mobile Vans, Pathology Labs, Ultrasound Centres, Blood Banks, Educational Institutions, Training Centres, Libraries, Reading Rooms, Yoga Training Centres, Sanskar Kendra, Senior Citizens Welfare Centres, Mukti Dhams & Legal Aid Cells etc.
- 23.2 The permanent projects can be broadly categorized in following areas:

a) Educational	214
b) Medical Care	337
c) Aid to Needy	316
d) Other Activities of Social Need	349

SAMPARK (PUBLIC RELATIONS)

- **24. Sanskriti Saptah**: 24.1 This annual programme of Vikas Week / Sanskriti Saptah is conducted during the months of July to September. It enables the members to work together in numerous programmes and helps create awareness about the work of the Parishad among the citizens. The main emphasis under this programme is on Sampark and Sahyog.
- 24.2 During the year 2014-15, **450 branches** organised **3,141 programmes** during the Sanskriti Saptah. These programmes were attended by **1.01 lakh citizens**.
- **25. Sthapana Diwas**: 25.1 On Parishad's Foundation Day branches organise functions to celebrate the event in order to spread its message among the citizens. During 2014-15, **529 branches** organised such functions where in **39,716 persons** participated.
- **26. Mahila Sahbhagita**: 26.1 During the year, branches organised **131 programmes** especially for women which were attended by **10,264 participants**. At Prant level, **16 Sahbhagita Samellans** were organised which were attended by **3,082 delegates**.
- **27. Seminars**: 27.1 Parishad's branches hold seminars on contemporary subjects of national interest and welfare of humanity in institutions of higher education to reinforce Bhartiya Sanskriti and Sanskars among the youth. During the year, **271 seminars** were organised seminars in which **40,915** persons participated.
- **28. Workshops**: 28.1 During the year, **204 workshops** were organised at Branch level while **79 workshops** were held at Prant level which were attended by **9,772 and 7,852 members** respectively.
- **29. Publications**: 29.1 Bharat Vikas Parishad is regularly bringing out its bilingual monthly journal "Niti" (circulation: 55,000 copies) in Hindi and English. Parishad is also publishing quarterly magazine "Gyan Prabha" to supplement "Niti" with thought provoking articles. This magazine fulfills the need to provide avenue for greater coverage of various issues which could not be accommodated in Niti due to space constraints.
- 29.2 Literature on Bharat Vikas Parishad, its projects and activities is being continuously revised and updated.
- 29.3 In addition, Branches and Prants brought out **36 and 34** publications at their levels.
- **30. Media Sampark**: 30.1 During the year Prants organized **179 press conferences** to brief the media about the activities of the Parishad.
- **31.** Parishad's Website & Social Media: 31.1 Parishad's website (www.bvpindia.com) continued to add new features to be a useful tool kit for conducting our programmes as well as an effective vehicle to disseminate information about the activities of the Bharat Vikas Parishad among the internet users. The website is now being accessed by over 4 lakh internet users from around the world.
- 31.2 It is noteworthy that e-versions of all **publications and membership data of Bharat Vikas Parishad are available on its website**. Among the new additions to the website are (a) Rashtriya Chetna Ke Swar (Hindi and Sanskrit songs) (b) Bharat Ko Jano (both English and Hindi versions).
- 31.3 Parishad is also using social media such as Facebook for spreading awareness about its work and to reach out to the younger generation. Now many Prants and Branches also have their presence on the Facebook.
